
Please be advised that our office never received any prior notice regarding the Uniform Business Report. I have notified your office of changes in business addresses in the year 2003 and 2004. I went online to print out proof of incorporation, to find out that my company has been involuntarily dissolved for failure to file 2003 and 2004 Uniform Business Report (UBR). However, attached please find two separate letters previously sent to your office advising of change of business address. This apparently was not changed in your system, as I never received the UBRs, nor is the new address reflected on the website.

Accordingly, attached please find Corporate Reinstatement Form, with attached fee of \$122.50 (representing \$61.25/year filing fee for UBR-years 2003 and 2004). We respectfully request that the \$600 reinstatement fee and \$177.50 (fee for each year dissolution \$88.75/year for 2003 and 2004) be waived.
