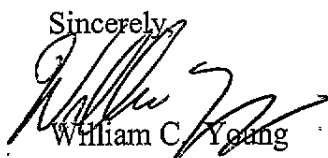

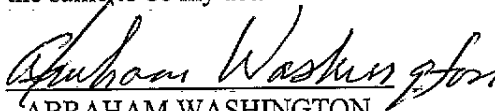
Pursuant to the provisions of Chapter 607.1006 et seq. of the Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is AWB BUILDING AND LAWN MAINTENANCE, INC.
2. The following amendment to the Articles of Incorporation were adopted by the Board of Directors of the corporation on November 13, 2001, in the manner prescribed by the Florida business Corporation Act:

ARTICLE I: NAME OF CORPORATION is hereby amended to indicate that the name of the corporation shall be: AWB REAL PROPERTY INVESTMENTS, INC.
