The undersigned, for the purpose of forming and organizing a corporation for profit under the provisions of the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is JOHN H. QUIRK, D.D.S., P.A.

<u> ARTICLE II - PURPOSE</u>

The purposes for which the Corporation is organized are to engage in the practice of Dentistry as permitted by Florida law.
