# ARTICLES OF INCORPORATION

The undersigned incorporator to these Articles Incorporation hereby form a corporation under the laws of the State of Florida as follows:

### ARTICLE I

### ARTICLE II

This Corporation shall have perpetual existence, commencing upon filing of these articles of incorporation with the Florida Secretary of State.
