ARTICLES OF INCORPORATION

OF

PAGAN COUNSELING INTERNATIONAL, INC.

ARTICLE I

NAME

The name of this Corporation is PAGAN COUNSELING INTERNATIONAL, INC.

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is:

ARTICLE III

NATURE OF BUSINESS
