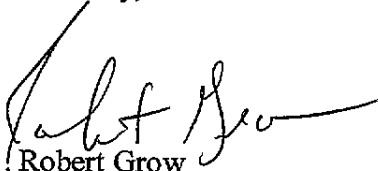
Dear Ms. Bullock:

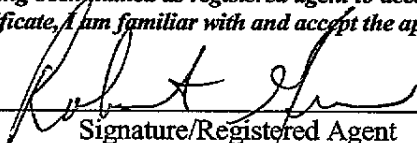
