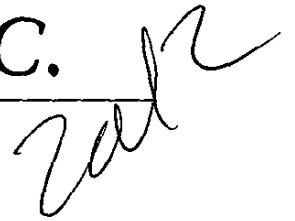

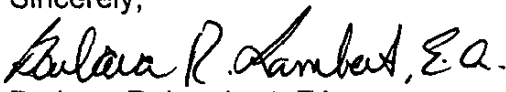
Dear Michele;
