ARTICLE I - NAME AND ADDRESS

The name of this corporation is W S ENTERPRISES, INCORPORATED,
located at 3341 NW 16TH Street, Miami, Florida 33125.

ARTICLE II - DURATION

The corporation shall have a perpetual existence.




