THE UNDERSIGNED, acting as sole incorporator of **AJ TOURS, INC.**, under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I
Name

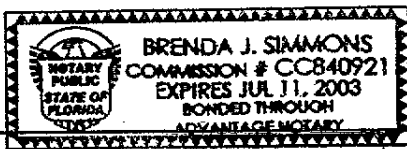




