**ARTICLE I
CORPORATE NAME**

DURATION

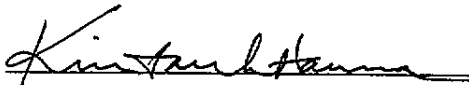
The duration of the Corporation shall be in perpetuity or until such a time as agreed upon by a quorum of the directors and shareholders.
