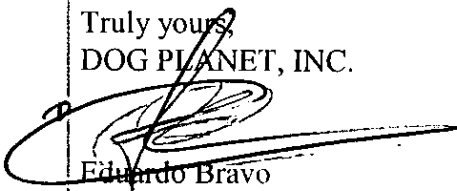
On 4/4/02 we mailed our check 1009 for \$150.00 with Uniform Business Report (UBR) covering the fees for the year 2002.
