### ARTICLES OF INCORPORATION

## THE REAL ESTATE CENTER OF LAKE COUNTY, INC. TALLAHASSEE FLOOR

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

#### ARTICLE I - NAME & ADDRESS

The name of this Corporation is THE REAL ESTATE CENTER OF LAKE COUNTY, INC. The principal office, if known, or the mailing address of the Corporation is 1938 Maple Circle, Tavares, Florida.

#### ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

#### ARTICLE III - PURPOSE

The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
