ARTICLE I - NAME

The name of this Corporation is INTERNATIONAL CREATIVE COMMUNICATIONS CORPORATION. The mailing address is: 2701 South Bayshore Drive, Suite 605, Coconut Grove, Florida 33133.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence. The Corporation shall commence existence on the date of the filing of these Articles of Incorporation by the Office of the Secretary of State of Florida.
