ARTICLES OF INCORPORATION

ARTICLE I - NAME

The undersigned, acting as incorporator for the purpose of forming a professional service corporation for profit under the provisions of Chapter 607 and Chapter 621, Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE II-

PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of the Corporation shall be 31 West Columbia Street, Suite 2, Orlando, Florida 32806.

ARTICLE III - DURATION

This corporation shall have perpetual existence commencing at the time of filing these Articles of Incorporation.

ARTICLE IV - PURPOSE

This corporation is organized to engage in the practice of general surgery as a professional corporation and to own and operate a medical facility for the purposes of providing general surgery, and medical research, and to own real any personal property, enter into contracts, and engage in any lawful business necessary for the rendering of such professional services; to invest its funds in real estate, mortgages, stocks, bonds or any other type of investments; to do everything necessary, proper or convenient for the accomplishment of any of the purposes herein set forth, and to do every other act incidental thereto which is not forbidden by the laws of the State of Florida or by the provisions of these Articles of Incorporation.

No shareholder of this corporation shall enter into a voting trust
