ARTICLE I.

The name of this corporation is Martha Monagan-Hart, Inc.

ARTICLE II.

PRINCIPAL OFFICE

ARTICLE III.

DURATION; EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of Florida.


ARTICLE X.
