ARTICLES OF INCORPORATION

OF Business Services Solutions And ATM Sales, Inc.

A Florida Corporation

Pursuant to Chapter 607 and 621, Florida Statutes

The undersigned persons have associated themselves for the purpose of forming a corporation under the laws of Florida and adopt the following Articles of Incorporation.

- Name. The name of this corporation is Business Services Solutions and ATM Sales, Inc. The period of duration shall be perpetual

- 8. Dealings by Directors.
