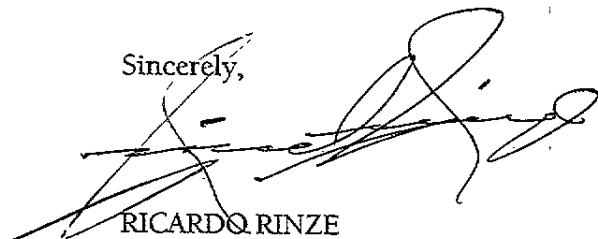

ARTICLES OF INCORPORATION  
OF  
SCRUBS FOR COMFORT, INC.

ARTICLE I: The name of this corporation shall be: SCRUBS FOR COMFORT, INC.

ARTICLE II: This corporation will engage in the transaction of any or all lawful business permitted under the laws of the State of Florida and the United States of America.

ARTICLE III: The maximum number of shares which the corporation is authorized to issue and have outstanding at any time is -50- shares of common stock, which shares shall be of TEN DOLLARS value each. All stock is to be issued as fully paid and exempt from assessment.

ARTICLE IV: The shareholders of this corporation shall have preemptive rights to acquire unissued or treasury shares of the corporation, or securities of the corporation, convertible into or carrying a right to subscribe to or to acquire shares of the corporation to the extent that the stockholders might so specifically set forth. Lacking this affirmative action by the stockholders, there shall be no such preemptive rights.

ARTICLE V: The amount of capital with which this corporation may begin doing business shall be not less than FIVE HUNDREDS DOLLARS.

ARTICLE VI: The existence of the corporation is perpetual.

ARTICLE VII: The initial office of this corporation shall be located at:  
4850 N.W. 108 Passage, Miami, Florida 33178, with the corporation retaining the power of moving its office to any other address in the State of Florida.

The register agent is: RICARDO RINZE, 4850 N.W. 108 Passage, Miami, Florida 33178.

ARTICLE VIII: The business of the corporation shall be managed by a Board of Directors consisting of two directors. A Quorum for the holding of meetings of the board of directors and for the transaction of any business which will be properly done by the directors on behalf of the corporation shall consist of a majority of the members thereof; but the directors, by unanimous consent in writing, included among the minutes of the corporation, may consent to the doing of any act and such consent in writing shall have the same force and effect as though a formal meeting had been held pursuant to call being duly made and as though the said act had been done and authorized at a meeting at which quorum had been present, or such duties may be delegated to an Executive Committee.

ARTICLE IX: The name and post office addresses of the members of first Board of Directors and the state of Corporate Officers are as follows:

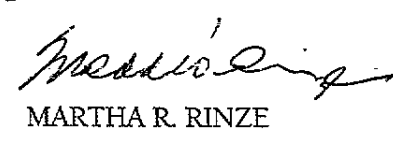
