**ARTICLE I - NAME**

The name of this corporation is **EXPEDICION AMERICA, CORP.**

**ARTICLE IX- INDEMNIFICATION**


The corporation shall indemnify any officer or Director, or any former Officer or Director, to the full extent permitted by law.


