ARTICLES OF INCORPORATION

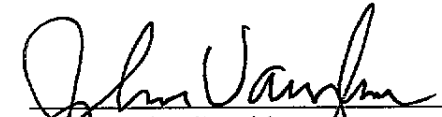
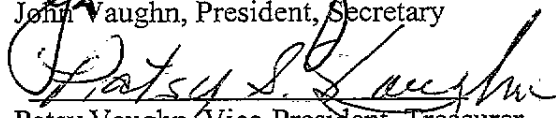
ARTICLE VIII

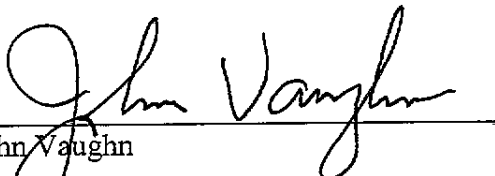

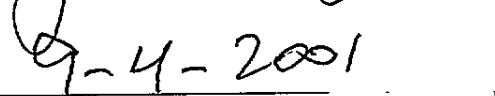
