Enclosed you will find the Articles of Revocation of Dissolution forms and a check in the amount of \$52.50 from Millennium 3000, Inc.

You will note on the forms that there are several entries that contain notations. As you will recall from our phone conversations, as we did not request that our Company be dissolved in the first place, some of the requests on the Revocation of Dissolution forms do not apply.

We've done the best we can with these forms considering that someone unknown to us, that has no connection whatsoever with our Company or any person in our Company filled out a Dissolution form and it was accepted by the State on face value, filed and our Company dissolved without any notice to us.

I understand that it would be a monumental task to check every signature on every form that your department receives, however, it would seem to me that a confirmation of some sort should go out to the Company involved just to be sure that the Company did indeed want that particular action to be taken. We found out about this only by accident. Otherwise we would not have known and the 120-day revocation period would have passed leaving us with no remedy to reverse the situation.

I appreciate all the assistance you and your staff have given me in resolving this awkward situation. Hopefully this will "red flag" this loophole in the system and something can be done to assure that this won't happen in the future.

On a suggestion from your staff I will be contacting the Attorney General's office and reporting this incident so perhaps they can go after the perpetrator.
