The name of this corporation is Chaykin Enterprises, Inc.

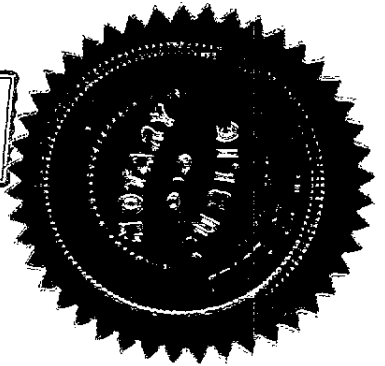
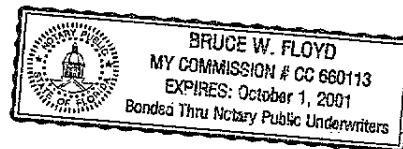


