WE THE UNDERSIGNED, hereby associated ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I - NAME

The name of this corporation shall be R J M ROOFING TILE, INC.

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted is sales and services including, but not limited to, maintenance and repairs and construction activities. The corporation may also engage in any activity or business permitted under the laws of the United States and the state of Florida, including the purchasing and selling of any real estate or personal property, or contracts for the same, and to have, and to exercise such general corporate powers as is now or may hereafter be given corporations organized under Florida Statutes 607 and amendments thereto.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock with the nominal or par value that the corporation is authorized to have outstanding at any time, together with the distinguishing characteristics of each and the nominal or par value of shares of stock are as follows:

a) The total authorized capital stock of this corporation is: One Thousand Dollars (\$1,000.00) divided into One Thousand (1,000) shares of the par value of One Dollar (\$1.00) each.

b) All of the stock shall be common and shall be fully paid and non-assessable and payable in cash, property, labor or services.

ARTICLE IV - BEGINNING CAPITAL

The amount of capital with which this corporation shall commence business is Five Hundred Dollars (\$500.00).

ARTICLE V - TERM OF EXISTENCE

The existence of this corporation shall be perpetual.

ARTICLE VI - PRINCIPAL ADDRESS

The resident agent for the corporation is Joseph A. Rosier, 559 S. Country Club Road, Lake Mary, FL 32746.


