## ARTICLES OF INCORPORATION OF S.B.S. PRINTING, INC..

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of Corporation is: **S.B.S. PRINTING, INC.** 

Article 2. Duration. The duration of the Corporation is perpetual.
