The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

## **ARTICLE I**

The name of this corporation is DIGITAL MEDIA PRODUCTIONS, INC., with its principal office located at 21 General Doolittle Road, Daytona Beach, Florida 32124.

#### **ARTICLE II**

This corporation shall have perpetual existence.

#### **ARTICLE III**

The general nature of the business to be transacted by this corporation is as follows:

- (a). To transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.
- (b). To own, operate and/or manage a computer networking business and to perform all related activities and services. To design and upgrade computer systems and networks. To purchase, acquire, lease, rent, sell and generally operate a computer design, network business.
- (c). To have a corporate seal, which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any manner reproduced.
