**ARTICLES OF INCORPORATION

**ARTICLE I. NAME**

The name of the corporation shall be FETTE CONCRETE, INC.

**ARTICLE II. DURATION.**

This corporation shall exist perpetually.

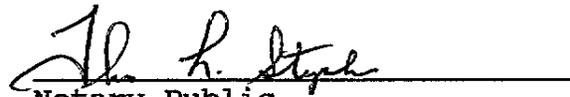

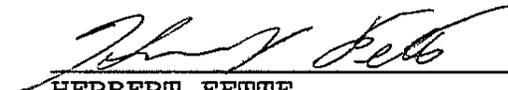
