ARTICLES OF INCORPORATION OF AROA ENTERPRISES, INC.

The undersigned, for the purposes of forming a corporation under the Florida general Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE ONE NAME

The name of the corporation is AROA Enterprises, Inc.
