ARTICLES OF INCORPORATION OF DAVID B. STEARNS, P.A.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract and legally authorized to practice in the profession of law in the state of Florida, hereby proceeds to form a professional corporation in accordance with the Florida Professional Service Corporation Act; and hereby adopts the following articles of incorporation for such corporation:

ARTICLE I NAME

The name of this Corporation is DAVID B. STEARNS, P.A.

ARTICLE IL PURPOSE AND NATURE OF BUSINESS

The purpose of the Corporation and the nature of its business are as follows:
