Name

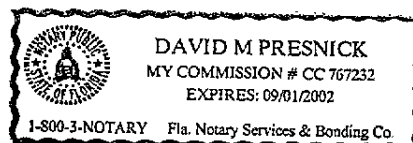


