Pursuant to the provisions of Section 607.1006, Florida Statutes, this corporation adopts the following Articles of Amendments to its Articles of Incorporation, specifically, ARTICLE IV SHARES, which is amended as follows:

ARTICLE IV SHARES

The maximum number of shares that this Corporation is authorized to issue and have outstanding at any one time shall be 1,000,000 shares of voting common stock, par value \$.001 per share. All shares of voting common stock shall be issued fully paid and exempt from assessment and shall be payable in lawful money of the United States, on any property, labor or services a just valuation to be fixed by the Board of Directors of the Corporation.
