Articles of Incorporation

Of

Smile Chong Corporation

THE UNDERSIGNED, ACTING AS INCORPORATOR OF A CORPORATION UNDER THE FLORIDA BUSINESS CORPORATION ACT, ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION:

FIRST: The name of the corporation is Smile Chong Corporation.

SECOND: The period of its duration is perpetual.

THIRD: The date of the commencement of the corporation existence shall be the date of filing.

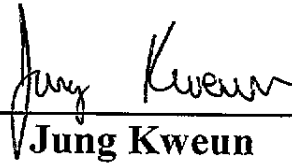

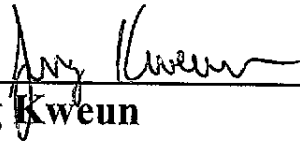
