# ARTICLES OF INCORPORATION \_\_ OF ALL FLORIDA UNIBODY AND FRAME INSPECTIONS, INC.

## ARTICLE I. - NAME

The name of this Corporation is ALL FLORIDA UNIBODY AND FRAME INSPECTIONS, INC.

## ARTICLE II. - DURATION

This Corporation shall exist perpetually.

## ARTICLE III. - PURPOSE
