

ARTICLES OF INCORPORATION  
OF  
ALL FLORIDA UNIBODY AND FRAME INSPECTIONS, INC.

ARTICLE I. - NAME

The name of this Corporation is ALL FLORIDA UNIBODY AND FRAME  
INSPECTIONS, INC.

ARTICLE II. - DURATION

This Corporation shall exist perpetually.

ARTICLE III. - PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business

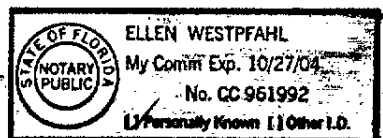
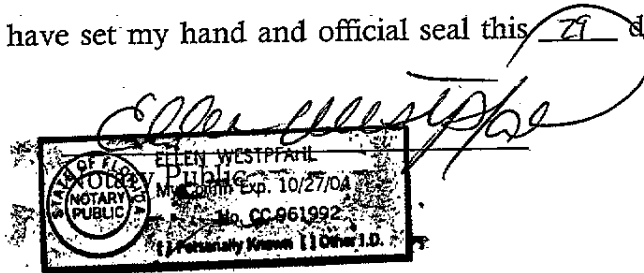
