# ARTICLES OF INCORPORATION

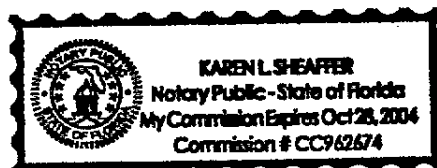
