ARTICLE I-Name

The name of this corporation is A.D. Barnes Farm, Inc.

ARTICLE II- Principal Office

The address of the principal office is 4321 Skipper Road, Sebring, Florida 33870.

ARTICLE III-Duration

This corporation shall have perpetual existence.

ARTICLE IV-Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE V-Capital Stock
