

**THE UNDERSIGNED**, acting as sole incorporator of BOGEY'S, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

**Name**

The name of the corporation shall be BOGEY'S, INC.

### **Initial Board of Directors**


