

ARTICLES OF INCORPORATION

OF

threeGmedia, Inc.

The undersigned, acting as incorporator of a corporation, hereby adopts the following Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation is **threeGmedia**, **Inc.** and the principal office address is **3473 N. Ocean Shore Boulevard**, **Flagler Beach**, **Florida 32137**.

ARTICLE II NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is **100,000** shares of common stock, each share having the par value of **\$.01** per share. The consideration to be paid for each share shall be fixed by the Board of Directors from time to time.
