ARTICLES OF INCORPORATION OF PRODIGY ENTERTAINMENT INCORPORATED

A FLORIDA FOR-PROFIT CORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, as amended, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I: NAME OF THE CORPORATION

The name of the Corporation shall be: PRODIGY ENTERTAINMENT INCORPORATED, hereinafter referred to as the "Corporation".
