**ARTICLES OF INCORPORATION
OF
ON TIME SEWER & PLUMBING, INC.**

The undersigned, for the purpose of forming a corporation, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is On Time Sewer & Plumbing, Inc., and its address is 731 Rock Hill Avenue, Davie, Florida 33325.
