**ARTICLE I**

## **ARTICLE XI**

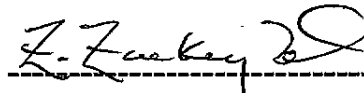

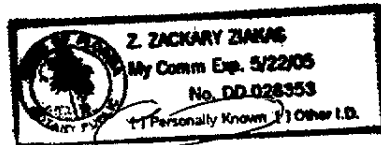

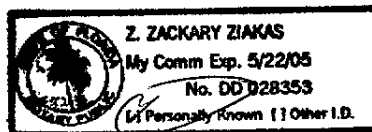
