Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendments adopted:

Article I is hereby amended as follows:

The name of the for-profit corporation of HARRISON & RIVARD, CHARTERED, is hereby amended to be a for-profit corporation known as HARRISON, RIVARD & ZIMMERMAN, CHARTERED.

Article V is hereby amended as follows:

This corporation is authorized to issue 1,500 shares of common stock, each having the par value of \$1.

Article VII is hereby amended as follows:

This corporation shall have three directors. The number of directors may be either

increased or diminished from time to time by the by-laws but shall never be less than one. The names and addresses of the directors of this corporation are:

THIRD: The date of each amendment's adoption shall be effective September 1, 2002.

FOURTH: Adoption of Amendments were approved by the board of directors without shareholder action and shareholder action was not required.
