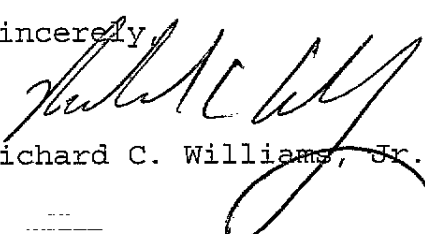

ARTICLE I - NAME

The name of this Corporation is Bar G Ozark, Inc.

ARTICLE II - PRINCIPAL OFFICE AND
MAILING ADDRESS OF CORPORATION

ARTICLE III - DURATION

ARTICLE VII - INITIAL BOARD OF DIRECTORS

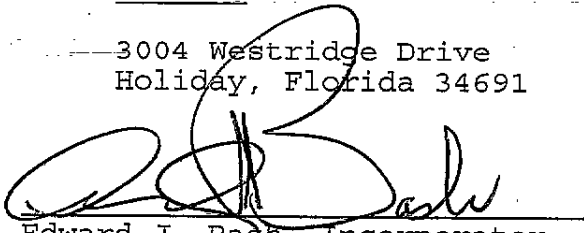

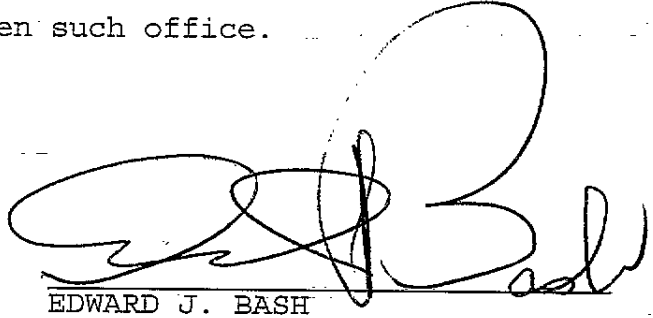
