The name of this corporation is TIMELESS WOOD DESIGNS, INC.

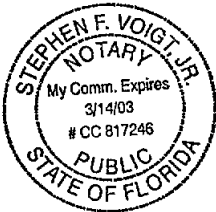



