**ARTICLE I: CORPORATE NAME**

The name and principal or mailing address of the Corporation are: Chambers Transportation Services Inc. 17701 NW 20<sup>th</sup> Ave., Carol City FL 33056.

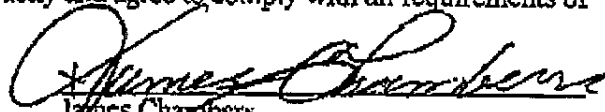

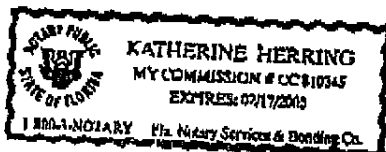

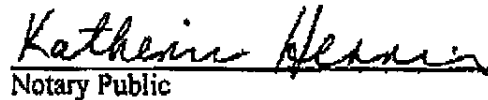
