Articles of Incorporation

FIRST: I, Richard H. Bernstein, whose post office address is 1761 W. Hillsboro Boulevard, Suite 321, Deerfield Beach, Florida 33442, being at least eighteen (18) years of age, hereby form a corporation under and by virtue of the General laws of the State of Florida.

SECOND: The name of the corporation (hereinafter called the "Corporation") is

**GOLDSTAR PUBLISHING CO.**

THIRD: The purposes for which the Corporation is formed are:

- (1) To engage in the business of publishing and to engage in any all activities incident thereto.
- (2) To purchase, lease and otherwise acquire, hold, mortgage, convey and otherwise dispose of all kinds of property, both real and personal, both in this state and in any part of the world.
- (3) To do anything permitted in the Florida Code, as amended from time to time.

FOURTH: The post office address of the principal office of the Corporation in this State is 1761 W. Hillsboro Boulevard, Suite 321, Deerfield Beach, Florida 33442. FIFTH: The total number of shares of capital stock which the Corporation has authority to issue is Sixty Thousand (60,000) shares, without par value.
