NAME

The name of the corporation is LIBERTY HOMES, INC.

INITIAL BOARD OF DIRECTOR/INCORPORATOR





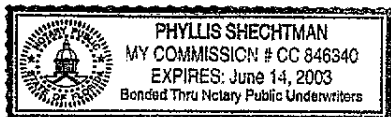
