Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendment adopted:

ARTICLE IV: SHARES is deleted in its entirety and replaced with the following:

"ARTICLE IV: SHARES

The maximum number of shares of stock that the corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having \$.01 par value per share, 500 shares of which will be Class A voting common stock and 500 shares of which will be Class B nonvoting common stock. The owners of the Class A voting common stock and of the Class B nonvoting common stock shall have identical rights to distribution and liquidation proceeds."

In all other respects, the corporation's Articles of Incorporation remain as originally constituted.

SECOND: The date of the amendment's adoption is effective as of September 18, 2001.

THIRD: The amendment was adopted by the Board of Directors without shareholder action and shareholder action was not required.
