THE UNDERSIGNED, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

- 1. **Name.** The name of this corporation is **THIRTY-SEVEN & FIFTY-ONE, CORP.**
- 2. **Duration.** The period of its duration is perpetual.
- 3. **Purpose.** The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.
- 4. **Capital Stock.** The corporation is authorized to issue 900 shares, all of one class, at \$1,000 par value.


