OF

**ARTICLE I. NAME**

The name of this corporation is CORN'S HYDRO SEEDING / LAWN SERVICE, INC.

**ARTICLE II. DURATION**

The corporation shall have a perpetual existence.

**ARTICLE III. PRINCIPAL PLACE OF BUSINESS**
