

CORPORATE NAME**



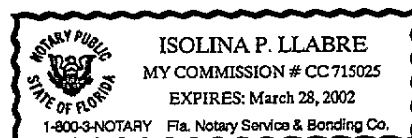


