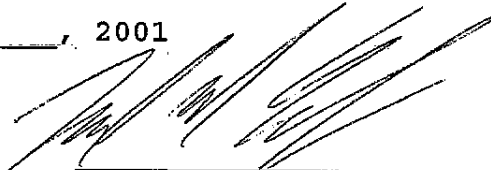
ACCEPTANCE OF REGISTERED AGENT
